CVMV2408129

CA Civil Code 46.

Slander is a false and unprivileged publication, orally uttered, and also communications by radio or any mechanical or other means which:

1. Charges any person with crime, or with having been indicted, convicted, or punished for crime;
2. Imputes in him the present existence of an infectious, contagious, or loathsome disease;
3. Tends directly to injure him in respect to his office, profession, trade or business, either by imputing to him general disqualification in those respects which the office or other occupation peculiarly requires, or by imputing something with reference to his office, profession, trade, or business that has a natural tendency to lessen its profits;
4. Imputes to him impotence or a want of chastity; or
5. Which, by natural consequence, causes actual damage.

CA Civil Code 1708.

Every person is bound, without contract, to abstain from injuring the person or property of another, or infringing upon any of his or her rights.

CA Civil Code 1708.7. (a)

A person is liable for the tort of stalking when the plaintiff proves all of the following elements of the tort:

- (1) The defendant engaged in a pattern of conduct the intent of which was to follow, alarm, place under surveillance, or harass the plaintiff. In order to establish this element, the plaintiff shall be required to support his or her allegations with independent corroborating evidence.

CA Civil Code 1708.8. (a)

A person is liable for physical invasion of privacy when the person knowingly enters onto the land or into the airspace above the land of another person without permission or otherwise commits a trespass in order to capture any type of visual image, sound recording, or other physical impression of the plaintiff engaging in a private, personal, or familial activity and the invasion occurs in a manner that is offensive to a reasonable person.

CA Civil Code 1710.

A deceit, within the meaning of the last section, is either:

1. The suggestion, as a fact, of that which is not true, by one who does not believe it to be true;
 2. The assertion, as a fact, of that which is not true, by one who has no reasonable ground for believing it to be true;
 3. The suppression of a fact, by one who is bound to disclose it, or who gives information of other facts which are likely to mislead for want of communication of that fact; or,
 4. A promise, made without any intention of performing it.

CA Civil Code 1711.

One who practices a deceit with intent to defraud the public, or a particular class of persons, is deemed to have intended to defraud every individual in that class, who is actually misled by the deceit.

This is the timeline the defendant provided the court in regards to me in her civil harassment

order she filed against me in 2023. It was denied and I left out the parts where she claims I am a prostitute. The 2005 incident she mentioned as the 2006 incident was dismissed as shown in the following documents. I have never asked her for anything. I paid for my own drone test. My entire family has been living off of me and lying about me since my birth. I just became aware that she was changing my records around and stealing from me on Sep. 4, 2024. I went to the records office and saw her working there..

I then came home and found my records with old cases open, I was listed on probation, had this child support judgement I had never seen and found a deed in my name from 2009 for half a million dollars. I wasn't ever made aware of any of these things and am positive there is more.

These actions violate every code mentioned previously and allow for injunctive relief.

Online harassment via social media or public embarrassment can be considered abuse. Actions which cause disturbance to another person's peace of mind can be considered abuse.

Slander: defamation that occurs in oral form. Libel: defamation that occurs in written form.

Threatened to show up at my job as well (Billy texts). False report to IdentityTheft.Gov (p27 – Cindy Texts). Kidnapping – Mom Text p11

Timeline

1993: Allowed her to live with me when homeless. She stole from my home while living inside, so I then allowed her to sleep in the garage with blankets and pillow on a large pool table with no access inside my home until I was home to monitor her. She was able to shower, eat, do laundry etc... She again bad mouthed me to family/friends about what a "bitch" I was to make her sleep in a garage.

2006: Used my identity during 2 traffic stops in different counties within days of one another. I only found out when I was renewing my drivers license and they had a noted hold on my record. I was living alone, 4 hours from any relatives or friends at the time with my 3 children. Had I been arrested for that, I have no idea how that would have impacted my children or employment. Her response, was "what kind of sister wouldn't have my back". She blamed me for years and continually bad mouthed me to family/friends. Had no contact with her for about 5-7 years after that incident.

2008: Mom was hospitalized and in after care for 2 months. During that time, I moved Patrick up with me, enrolled him in school, and gave him and my mother a new home. Patti never assisted, never offered, never visited, never offered financial, or any other type of support. Both my mother and Patrick have been with me ever since.

2017: Arrested and spend 113 days in jail for attempting to illegally transport someone into the US from Mexico. Asked for money for attorney fees.

2018: I paid for her to fly up to us in Washington state to help watch my mother while I was going on my honeymoon. She agreed, and flew up. 3 days into her trip, she became frantic that she needed to leave because she feared Queen was being mistreated at her residence. The same residence she lives at now. My mother had to pay for the change in return flight and the \$100 Uber ride to the airport. Had little/no contact with her until she asked for money in 2019.

2019: Asked me to pay for her to take a "drone" state exam. I told her I would not give her the money. Again, I was a "bitch" who thinks she's better than everyone else.

2021-2022: She is unemployed, and frequently asked us to provide gas money for her. Asked if she'd be interested in cleaning my house for pay to help her out. She did it once and I paid her. Asked if she'd like to do it again, after her not showing up for two days, she told me to leave my back door open and she'll show up after 1am. I told her I would not leave my door open and if she couldn't be at my house before 11pm, not to come. Her response was to tell me I'm not in control of everything and that I expected her to be a servant. That she has a life and she'll come when she can. I told her forget it, that when I'm paying for a service, it will be done on my terms.

2023: Has been permanently banned from Twitter, Uber, Lyft, and Doordash. She's filed frivolous lawsuits against Lyft according to the records. Can produce those records.



They have my dog.





Course Information

This diploma course about reading Tarot cards provides all the information you need to become a skilled Tarot card reader. We first present you with a brief history of Tarot and discuss how to choose and care for the perfect deck. We then explain how to perform Tarot card readings as a beginner. This course helps you to get the most out of the ancient art of Tarot reading as you learn how to interpret symbols to tell stories. A Tarot deck consists of 78 cards, divided into Major and Minor Arcana, and we cover both. Our overview of the history of Tarot begins in Egypt with the set of letters that are the precursors to Tarot cards before they were introduced in Italy in the late 15th century. The Minor Arcana were made up of four suits similar to those we still see today: cups, swords, sticks and coins. A symbolic and interpretive plan begins to be attributed to each element, highlighting specific figures by order of importance.

Tarot cards have since become a popular tool used to tell stories that resonate via their symbolism. Professionals use them to help people find answers to personal questions, face and overcome challenges and cope with life changes. They can offer comfort or provide psychological guidance when people want it most (but should never be substituted for serious professional help when it is needed). As a Tarot reader, you can be the one to provide that kind of help to friends, family, strangers and even yourself. Personal projection is one of the main reasons these cards are so valuable as we interpret their ancient archetypes and symbols and apply them to our own experiences. As a skilled practitioner, you can help yourself and others to interpret the cards and apply their symbolism and stories to real life. This course studies various Tarot spreads used to organise the cards to help you decide when to use each. We examine some of the most common spreads for beginners in detail.

This diploma course then provides multiple Tarot sheets and information on reading. We go over the strategies and techniques that successful readers use when preparing to lay out cards and explain how to set the mood. We also provide tips on how to read yourself and emphasise the need to eliminate bias. We discuss ethical considerations that Tarot readers should be aware of and explain how to conduct readings for others responsibly. Finally, we talk about working as a professional Tarot card reader. The course explains
